3. Retention periods

The personal data will not be retained longer than necessary and will be removed from the records within the specified period, according to the processing register of Wendy van der Voort.

- 3.1. Personal data for registration to a real estate property will be retained for up to 1 year after the business relationship ends:
- 3.2. Personal data for client due diligence under the Wwft will be retained for up to 5 years after the business relationship ends;
- 3.3. General information will be retained for up to 20 years after the business relationship ends.

4. Rights

- 4.1. Right to object. You have the right to object to the processing of your personal data at any time, for example, if you believe that the use of your personal data is not necessary for the execution of our activities.
- 4.2. Right to access. You have the right to access your personal data. You can request your registered personal data at any time, the purposes for which they were used, and the recipients of your personal data.
- 4.3. Right to rectification. If you believe that we possess incorrect personal data about you, you have the right to have this data corrected.
- 4.4. Right to erasure. You have the right to have your personal data erased without undue delay. We are obliged to comply with your request unless we have a compelling legitimate interest not to delete the data.



5. Security of personal data

Wendy van der Voort takes all appropriate security measures to treat and protect your personal data with the utmost care. In all cases, Wendy van der Voort complies with the applicable laws and regulations, including the General Data Protection Regulation.
